Independent Living Event – 26/6/14

Introduction

Thurrock Coalition offers advice and support for disabled and older residents of Thurrock and their carers. We are a wide network of individuals and groups aiming to inform people about their rights and entitlements and to improve the quality and choice of services that might assist them.

Background

The Thurrock Coalition Independent Living Event was the result of 3 months planning, consultation and co-ordination between individuals and groups throughout the Coalition networks across Thurrock. The event planning was spearheaded and co-ordinated by Thurrock Coalition with support from the Coalition partners, namely Thurrock Centre for Independent Living (TCIL), Thurrock Lifestyle Solutions (TLS), Thurrock Mind and Thurrock Diversity Network (TDN).

The event itself comprised of 23 stallholders and attracted over 160 individuals, representatives, groups, organisations and companies on the day and provided an excellent opportunity for awareness raising, information sharing and networking for all attendees. It is hoped that such links will strengthen the foundations of the sector and provide a basis for similar public events in the future.

The Purpose

The purpose of the event was to provide a platform for Advice, information and guidance for disabled people, older people and carers, living in Thurrock. In particular to showcase the range of information, support services, products, ideas and innovation that is available to support independent living in the borough.

The Audience

The event was primarily aimed at people who use Adult Social Care, to provide an opportunity to learn about the services available to them locally in Thurrock to support them to live independent lives.

Local Organisations (Private/Voluntary/Independent) were invited as exhibitors/stallholders, and to give them an opportunity to highlight products and increase awareness about their services to an ever increasingly powerful customer base.

Professionals were also invited (e.g. People working in Social Care/Health/the Third Sector), to provide them with an opportunity to publicise the support services they offer and to learn about the diversity of services available so they are better able to support clients, family members and carers. This was achieved through the use of "Independent Living Scenarios" for attendees to read and then utilise the resources in the room in order to find positive and creative solutions for the people depicted in the Scenarios.

We also co-ordinated the filming of a short informative video that asked a number of TCIL clients the following questions, and recorded their responses verbatim:

- 1). What does Independent Living mean to you?
- 2). How has Thurrock Centre for Independent Living made a difference to your life?
- 3). What are your best hopes for the future?

4). What advice would you give someone looking for information & support in Thurrock?

The video successfully illustrated the value and importance of the holistic, person centred approach offered by TCIL in terms of information, advice, guidance and advocacy on a wide range of issues affecting disabled people in Thurrock.


